

LEVELLING UP AND REGENERATION ACT 2023 AND THE ABOLISHMENT OF THE "4 YEAR RULE" – MAY 2024 UPDATE.



## **OVERVIEW**

I wrote back in March about a significant change that the Levelling Up and Regeneration Act 2023 had made to the planning system. The Government had legislated to abolish the rule that prevents enforcement action being taken against certain types of unlawful development after 4 years and extend it to 10 years, bringing it into line with the rules for enforcing against unlawful changes of use that aren't residential.

I also wrote about the uncertainty of the changes to these rules being confirmed, but there not being any indication of when they might come into effect. Clarity on this was of course provided within weeks of the article being finalised.

## **OUTCOME & UPDATE**

On 2 April 2024, the Planning Act 2008 (Commencement No. 8) and Levellingup and Regeneration Act 2023 (Commencement No. 4 and Transitional Provisions) Regulations 2024 (2024 Regulations) were made. The effect of these 2024 Regulations is that Section 115 of the Levelling Up and Regeneration Act 2023 becomes effective from 25 April 2024 and amends 171B of the Town and Country Planning Act 1990 (1990 Act) by deleting the word four and replacing it with the word ten.

I speculated on whether there would be any transitional arrangements and this was confirmed in the 2024 Regulation which do include transitional provisions to ensure that the amendments to 171B of the 1990 Act made by section 115 won't apply to any breaches which occurred (in the case of operational development the date of the breach being the date the operations were substantially completed) before 25 April 2024.
